A clear indication of an increased risk of cancer in humans has so far not been shown. No carcinogenic potential can be deduced from other studies with rats and mice. The American Conference of Governmental Industrial Hygienists (ACGIH) has classified this substance as Group A3 - animal carcinogen.
